EDUCATION BUREAU CIRCULAR NO. 6/2011

Pre-primary Education Voucher Scheme

[Note: This circular should be read by -

- (a) Supervisors and Heads of Kindergartens/Kindergarten-cum-Child Care Centres and Schools with Kindergarten Classes - for action; and
- (b) Heads of Sections for information.]

Summary

This circular invites kindergartens, kindergarten-cum-child care centres and schools with kindergarten classes (hereafter collectively referred to as "KGs") to submit application for joining the Pre-primary Education Voucher Scheme (PEVS) in the 2012/13 school year.

Background

2. The implementation of the PEVS beyond the 2011/12 school year is subject to review. Hence, in accordance with the existing terms and conditions of the PEVS, the validity period of being an eligible KG under the PEVS is due for expiry by the end of the 2011/12 school year. Pursuant to the recommendations of the Report on Review of the PEVS (December 2010), the existing PEVS as a mechanism for providing direct fee subsidy for parents to pay for KG education will be enhanced in its next phase of implementation starting from the 2012/13 school year.

Details

Eligibility Criteria for Joining PEVS

- 3. Registered KGs wishing to apply for admission to the PEVS should
 - (a) be a non-profit-making KG which is exempt from taxes under Section 88 of the Inland Revenue Ordinance (CAP.112);
 - (b) offer a full local curriculum in accordance with the Guide to the Pre-primary Curriculum (issued by Curriculum Development Council, Hong Kong); and
 - (c) charge a tuition fee not exceeding the specified fee thresholds.
- 4. As of the 2011/12 school year, the fee thresholds for a half-day place and a whole-day place are \$24,000 and \$48,000 respectively per student per annum (pspa). With effect from the 2012/13 school year, the Education Bureau (EDB) will conduct annual review, with the fee thresholds either increased annually according to the year-on-year rate of change in

Composite Consumer Price Index (CCPI) or frozen in case of deflation. In the latter case, the fee thresholds will be raised again in subsequent years only when the accumulated increase has offset the accumulated decline.

5. A KG operating both half-day and whole-day classes would have to meet both school fee thresholds in order to be an eligible KG under the PEVS. KGs and KG classes offering an international curriculum will not be eligible for joining the PEVS.

Value of Voucher

6. The voucher value in and beyond the 2012/13 school year for parents to defray the tuition fee of KG education for their children will be adjusted annually on the basis of the 2011/12 school year level of \$16,000 pspa according to the year-on-year rate of change in CCPI. With effect from the 2012/13 school year, the portion of KG tuition fee to be met by the voucher will be disbursed to the PEVS-KGs according to their tuition fee payment schedules to streamline administrative and accounting procedures.

Professional Qualifications and Certificate Teacher to children ratio

- 7. PEVS-KGs should employ sufficient number of teachers possessing the Certificate in Early Childhood Education (C(ECE)) qualifications based on the teacher to children ratio of 1:15. To help retain experienced teachers and smoothen transition towards professional upgrading, EDB may, until the end of the 2013/14 school year or under special circumstance, consider teachers pursuing the C(ECE) qualifications as C(ECE) teachers for the purposes of meeting the 1:15 C(ECE) teacher to children ratio requirement. PEVS-KGs meeting the above requirement may continue to employ non-C(ECE) teachers with Qualified Kindergarten Teacher qualifications, or a qualification acceptable to the Permanent Secretary for Education.
- 8. Principals newly appointed to the PEVS-KGs should have a degree in early childhood education (BEd(ECE)), one-year post-qualification experience and should have completed a recognised certificate course on principalship, before, or exceptionally within the first year of, their appointment.

Quality Review and Transparency

- 9. Quality Review (QR), comprising KGs' self-evaluation and external review by EDB, promotes quality education and sustain capacity enhancement. Hence, PEVS-KGs are required to conduct self-evaluation for continuous improvement, to be validated by EDB. Only KGs meeting the prescribed quality standards under the QR framework are eligible for joining the PEVS. EDB will separately advise KGs on the operational details of the QR in its next phase of implementation.
- 10. PEVS-KGs should meet the transparency requirement by disclosing its key operational details (including but not limited to the name of its approved supervisor and

principal, the number, qualification and salary range of the principal and teachers, student enrolment, school facilities and activities, the curriculum, school finance information, tuition fees and any additional charges for optional activities and items) and consent to publish such information in the Profile of Kindergartens and Kindergarten-cum-Child Care Centres (KG Profile) issued by EDB from time to time to the public.

Terms and Conditions of the PEVS

The "Terms and Conditions of the Pre-primary Education Voucher Scheme" ("Terms and Conditions") is at **Appendix I**. Call circular on admission of KGs to the PEVS will be issued annually.

Other Information

Certificate of Eligibility

12. Only children reaching 2 years 8 months of age or above on the 31st day of August of the school year in which they seek admission to an eligible KG may apply to the Student Financial Assistance Agency (SFAA) for the "Certificate of Eligibility for Pre-primary Education Voucher Scheme".

Fee Remission

- 13. Needy families may apply for additional financial support under the Kindergarten and Child Care Centre Fee Remission Scheme (KCFRS) administered by SFAA. With effect from the 2011/12 school year, the KCFRS has been modified to provide enhanced assistance to KG children of needy families as follows
 - (a) calculate the percentage of fee remission after deducting the voucher subsidy;
 - (b) remove the social needs assessment in processing applications for fee remission for children attending relevant classes in whole-day PEVS-KGs; and
 - (c) adjust annually the meal allowance ceiling for needy KG children attending whole-day PEVS-KGs with reference to the annual movement of Consumer Price Index (A).
- 14. The above enhancement details are available for browsing at SFAA's webpage at http://www.sfaa.gov.hk/eng/schemes/kinder.htm.

Action Required

For KGs not intending to stay in PEVS

15. Existing PEVS-KGs not wishing to continue to stay in the PEVS in the 2012/13 school year should submit to EDB **Appendix II** <u>not later than 31 October 2011</u>. Existing students of these KGs will continue to receive the voucher until they leave the PEVS-KG concerned.

16. Without prejudice to the Government's power to terminate the PEVS-KGs being an eligible KG under the PEVS under Clause 8 of the existing "Terms and Conditions in respect of Pre-primary Education Voucher Scheme for Non-Profit-making Kindergartens" stipulated in EDB Circular No. 1/2007, EDB reserves the right to exclude PEVS-KGs from the PEVS when they are found not meeting the quality standards or with a track record of fraudulent practices.

For KGs intending to stay or newly join PEVS in 2012/13

- 17. Existing PEVS-KGs wishing to stay in the PEVS in the 2012/13 school year should return the completed application form at **Appendix III** to the Kindergarten and Support Section, Support Services Office of EDB on or before **28 November 2011 (Monday)**. EDB will inform the applicants of the result of their applications not later than 9 March 2012 (Friday).
- 18. KGs not yet in the PEVS but wish to apply to join the PEVS in the 2012/13 school year should also return the completed application form at **Appendix III** to the Kindergarten and Support Section, Support Services Office of EDB on or before **28 November 2011** (Monday). EDB would inform the applicants of the result of their applications not later than 30 March 2012 (Friday).
- 19. The list of approved NPM KGs joining the PEVS in the 2012/13 school year by district will be available for browsing at EDB webpage on "New Milestone of Pre-primary Education" at http://www.edb.gov.hk/index.aspx?nodeID=5792&langno=1 in April 2012.

Implementation Arrangements

- 21. The voucher value and fee thresholds for the 2012/13 school year will be announced in the EDB circular memorandum inviting application for fee revision for the 2012/13 school year to be issued in mid-January 2012.

1. If a kindergarten/kindergarten-cum-child care centre/school with kindergarten classes is approved by the Government of the Hong Kong Special Administrative Region ("Government") to join the PEVS ('PEVS-KG'), the PEVS-KG shall fulfill and meet all the requirements and specifications set out in Education Bureau Circular No. 6/2011 dated 21 October 2011 on "Pre-primary Education Voucher Scheme" ('EDBC No. 6/2011') (including but not limited to the terms and conditions as set out below).

2. The PEVS-KG shall:

- (a) be a non-profit-making kindergarten which is exempt from taxes under Section 88 of the Inland Revenue Ordinance (CAP. 112);
- (b) charge a tuition fee not exceeding the prescribed fee thresholds as specified by the Government in writing for a half-day place and a whole-day place. The fee thresholds for the 2012/13 school year will be adjusted according to the yearon-year rate of change in the Composite Consumer Price Index (CCPI) and frozen in situation of deflation. Both tuition fees thresholds for half-day KGs and whole-day KGs shall be met by the PEVS-KG whenever the PEVS-KG operates both half-day and whole-day classes;
- (c) offer a full local curriculum in accordance with the Guide to the Pre-primary Curriculum issued by the Curriculum Development Council of Hong Kong;
- (d) meet the transparency requirement by disclosing its key operational details (including but not limited to the name of its approved supervisor and principal, the number, qualifications and salary range of the principal and teachers, student enrolment, school facilities and activities, the curriculum, school finance information, tuition fees and any additional charges for optional activities and items) and consent to publish such information in the Profile of Kindergartens and Kindergarten-cum- Child Care Centres issued from time to time by the Government to the public;
- (e) submit annually at a date to be specified by EDB a copy of audited account covering the whole school year to EDB for inspection. The accounts shall be audited, dated and signed by a certified public accountant (practicing)/certificated public accountant registered under the Professional Accountants Ordinance (CAP. 50). The amount of subsidy received by the PEVS-KG under the PEVS shall be accurately and properly reflected in the audited account;

- (f) keep accurate records of all income and expenditure relating to the operation of the PEVS-KG and submit the same to EDB for inspection as and when required;
- (g) not transfer the surplus, in whatever form, to any of their sponsoring bodies or other organisations;
- (h) at all times comply with the Education Ordinance (CAP. 279) and Education Regulations (CAP. 279A) and maintain an operating standard in both management and professional aspects acceptable to the Government;
- (i) comply with the standing administrative directives including but not limited to the requirements of (a) meeting the minimum 1:15 teacher to child ratio with teachers possessing the Certificate in Early Childhood Education [C(ECE)] qualification; and (b) the possession of the prescribed qualification requirements as specified by the Government in writing by its approved principal; and such other instructions and directives as EDB may from time to time issue in relation to the provision of nursery and kindergarten education; and
- (j) inform EDB in writing together with all the related documents in the first instance when there are any changes in its operation, including but not limited to its NPM status that shall affect its eligibility under the PEVS.
- 3. The PEVS-KG will be paid for each student who is undergoing nursery (K1) and kindergarten education (K2 and K3) in the PEVS-KG and has been issued a valid "Certificate of Eligibility for Pre-primary Education Voucher Scheme" ('PEVS-student') a subsidy of the voucher value.
- 4. (a) Where the approved tuition fee of a school year exceeds the value of the voucher for fee subsidy for that school year, the PEVS-KG can only collect the difference between the two amounts by monthly instalments as shown on the Fees Certificate issued under regulation 60A of the Education Regulations (CAP. 279A) to the PEVS-KG from the parents of PEVS-student.
 - (b) Where the tuition fee is lower than the value of the voucher for fee subsidy, PEVS-KG is only entitled to redeem the exact amount of the tuition fee from EDB and shall not ask parents to pay any tuition fee.

- 5. If the PEVS-KG is no longer eligible under the PEVS, the PEVS-KG shall return the unspent balance of the subsidy granted to the PEVS-KG under the PEVS in FULL as determined by EDB to the Government within the period as specified by the Government in writing.
- 6. Upon EDB's request, the PEVS-KG shall submit school self-evaluation report(s) (in the format as agreed by the Government) to EDB within a period as specified by the Government in writing.
- 7. Without prejudice to the Government's power to terminate the PEVS-KG being an eligible kindergarten under the PEVS under Clause 9 below, in the event that the PEVS-KG fails to comply with or observe any of the provisions set out in EDBC No. 6/2011 (including without limitation, these terms and conditions), the Government may forthwith defer/stop the payment of the subsidy to the PEVS-KG and may by notice in writing to the PEVS-KG directing / requiring the PEVS-KG to make good and rectify the non-compliance in accordance with such directives / requirements by the date as specified by the Government in the notice. The PEVS-KG shall comply with such directives and requirements.
- 8. Without prejudice to the Government's power to terminate the PEVS-KG being an eligible kindergarten under the PEVS under Clause 9 below, in the event that the PEVS-KG has withdrawn or has been excluded from the PEVS for having found not meeting the quality standards or with a track record of fraudulent practices, existing students of the PEVS-KG will continue to receive the voucher until they leave the KG concerned.
- 9. If the PEVS-KG fails to comply with or observe any of the provisions set out in EDBC No. 6/2011 (including without limitation, these terms and conditions), the Government is entitled to forthwith terminate the PEVS-KG being an eligible kindergarten under the PEVS by notice in writing to the PEVS-KG and forthwith cease to grant any subsidy under the PEVS to the PEVS-KG.
- 10. Notwithstanding anything provided herein, the Government reserves the right to make any adjustments in the subsequent payment(s) payable to the PEVS-KG under the PEVS to recoup any overpayment previously made by the Government under the PEVS to the PEVS-KG, and upon the Government's request, the PEVS-KG shall forthwith repay the extra amounts paid by the Government to the PEVS-KG under the PEVS.

- 11. The PEVS-KG shall not, and shall ensure that its employees, agents and consultants shall not, make or give any specific gifts, discount, rebates or any other concession or financial inducements of whatsoever form to parents of PEVS-student or any other persons in return for such parents or persons requiring or inducing the PEVS-students enrolling in the PEVS-KG.
- 12. Any form of splitting or sharing of the subsidy redeemed or redeemable from the voucher between the PEVS-KG and the parents of PEVS-student or any other persons or any other kindergartens or organizations in return for the PEVS-student enrolling in the PEVS-KG, or such parents or persons or kindergartens or organizations requiring or inducing the PEVS-student enrolling in the PEVS-KG, is strictly prohibited.
- 13. The PEVS-KG shall fully cooperate with the officers and agents of EDB and other persons duly authorized by the Government and promptly provide all relevant information and documents which any one of them may from time to time request for inspection, verification, photocopying or otherwise for the purpose of administration and monitoring the operation of the PEVS.
- 14. The PEVS-KG shall comply with all instructions and directives as EDB may from time to time issue in relation to the PEVS.
- 15. The PEVS-KG shall indemnify and keep indemnified the Government from and against:
 - (a) all and any claims, actions, investigations, demands, proceedings, threatened, brought or instituted against the Government; and
 - (b) all liabilities (including liability to pay compensation and damages), damage, losses, costs, charges and expenses which the Government may sustain or incur (including all legal and other costs, charges, and expenses, on a full indemnity basis, which the Government may pay or incur in relation to any claim, action or proceeding instituted by, or against, the Government),

which in any case arise directly or indirectly from, or as a result of, or in connection with, or which relate in any way to:

- (i) any non-compliance by the PEVS-KG of any of the provisions set out in EDBC No. 6/2011 (including without limitation, these terms and conditions); or
- (ii) the negligence, recklessness, or willful misconduct on the part of the PEVS-KG or on the part of any employee, agent or consultant of the PEVS-KG in the operation/implementation of the PEVS.

- 16. All rights and powers of the Government hereunder may be exercised by the Permanent Secretary for Education for and on its behalf.
- 17. Notwithstanding anything herein to the contrary, clauses 2(d), 2(e), 2(f), 2(g), 2(h), 2(i), 2(j), 5, 10, 13, 14, 15 and 16 of these terms and conditions shall continue to have full force and effect and constitute binding obligations on the PEVS-KG notwithstanding termination of the PEVS-KG being an eligible kindergarten under the PEVS in the manner mentioned in clause 9 above.

- 4. All documents submitted are not returnable. Data subject have the right to obtain access and make corrections to the personal data in the application in accordance with Sections 18 & 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of the Hong Kong Special Administrative Region).
