Primary Education Curriculum Guide — Theme-based Onsite Workshop



### Summary

This circular memorandum is to inform primary schools about the Primary Education Curriculum Guide — Theme-based Onsite Workshop to be organised by the Education Bureau (EDB) from the 2023/24 school year and invite interested schools for enrolment.

#### Background

2. Since the Primary Education Curriculum Guide (PECG) (Pilot Version) (2022) prepared by the Curriculum Development Council (CDC) was published for use by schools in September 2022, the Education Bureau (EDB) has been providing schools various kinds of supports, such as the related series of teachers' professional



development programmes and promotional videos for the PECG, articles, posters and instant messenger stickers, etc. Besides, the 3-year Primary School Leaders' Workshop (PSLW) on Whole-school Curriculum Planning for all the government, aided (including special schools) and Direct Subsidy Scheme (DSS) primary schools organised by the EDB was finished in late June 2023. The primary school sector agreed that the PSLW could facilitate schools' whole-school curriculum planning and professional exchanges. As such, the EDB is going to organise the **Primary Education Curriculum Guide** — **Theme-based Onsite Workshop** (hereafter referred to as the Workshop), starting from the 2023/24 school year (for three school years till the 2025/26 school year tentatively) to provide ongoing support for schools in implementing the major renewed emphases in the PECG, optimising the whole-school curriculum planning and enhancing teachers' professional capacity. The Workshop is <u>open for schools' enrolment in accordance with their school context and teachers' professional needs</u>.

## Details

3. **Workshop arrangements and themes**: Each onsite workshop is a half-day session (usually lasts for 1-2.5 hours in either A.M. or P.M., and the actual duration is subject to further discussion with the participating school(s)) to be held at a designated venue in the participating school. The Workshop covers the major renewed emphases in the PECG, including the designated theme on "assessment literacy and assignment policy". Apart from this, schools can choose other themes (maximum <u>TWO themes</u>) related to curriculum development in the PECG. The details are as follows:

# Designated theme in primary curriculum development

✓ Assessment literacy and assignment policy (including the use of diversified assessments to replace test and examination in the first term of primary one)

Other themes for schools' selection in primary curriculum development (maximum TWO themes)

- □ The updated seven learning goals of primary education
- □ Whole-school curriculum planning
- □ Major renewed emphases: Values Education (including life education, national education and national security education)
- □ Major renewed emphases: Making good use of learning time and creating space
- □ Interface between kindergarten and primary
