# Incorporated Management Committee Liability Insurance Policy (IMCLIP) for the 2024/25, 2025/26, and 2026/27 School Years

### **Summary**

This circular memorandum informs all aided schools which have established their incorporated management committee (IMC) that QBE Hongkong & Shanghai Insurance Limited (QBE) is the successful tenderer for the IMCLIP for the 2024/25, 2025/26, and 2026/27 school years. It also serves to remind the points to note.

#### **Details**

- 2. On top of the legal protection conferred by the Education Ordinance, the IMCLIP, arranged by the Education Bureau (EDB) on behalf of aided IMC schools, protects the IMCs and their managers from legal liability as a result of claims arising from their wrongful acts in performing school management duties. From 1 September 2024 to 31 August 2027, QBE will be the Insurer for the IMCLIP, which insures both the IMCs of these schools and their managers, and covers management liability, vicarious educator liability and employment-related matters.
- 3. A brief description of the IMCLIP coverage, administrative arrangements for the IMCLIP and the Common Questions and Answers have been uploaded onto the EDB Homepage at <a href="https://sbm.edb.gov.hk/en/references/imclip/index.html">https://sbm.edb.gov.hk/en/references/imclip/index.html</a> for reference by schools.
- 4. Schools are reminded that in accordance with the policy terms and conditions, on the happening of any occurrence of a claim or a circumstance that is likely to give rise to a claim under the IMCLIP, the schools concerned shall <u>not</u> answer any correspondence from the persons concerned or solicitors. The schools are required to notify the Insurer (that is, QBE for the 2024/25, 2025/26, and 2026/27 school years) in writing as soon as reasonably practicable. Schools shall not negotiate, pay, settle, repudiate any claim, make any admission or offer without the written consent of the Insurer, and shall not accept any payment or arrangement of indemnity offered by any third party held responsible for the loss or damage. Any interpretation of the above-mentioned reminder should be based on the full-text of the policy.
- 5. The Certificate of Insurance and a copy of the policy will be issued to schools in late August 2024. The said documents should be kept properly as they provide the relevant information for access to Claim Hotline when necessary. If schools do not receive the said documents after 10 September 2024, please contact the Insurer through the Policy Related
